### **Camping rules** SV Bundesqualifikation FCI 2017

#### 1.) Scope:

The camping rules apply for all guests and visitors to the campsite of Tauchaer Sportverein e.V. Entering the site represents implicit consent to the site rules as well as any applicable legal or official regulations.

#### 2.) Registration and space assignment:

Only campers who reserve a space on time by 2 June 2016 will be considered. Campers that are not registered are not guaranteed to receive a space. The local group staff will decide where the tents of individual campers including their vehicles or caravans with towing vehicles are allowed to remain in the car park.

#### 3.) Arrival and departure:

Arrival is possible no earlier than Thursday, 22 June 2017 at 2 pm. Departure is possible no later than Monday, 26 June 2017 at 12 pm.

#### 4.) Fees:

Fees will be charged according to the campsite price list and must be paid in cash on arrival.

#### 5.) Night-time ban on noise:

From 10 pm to 6 am, noise is not permitted.

#### 6.) The following is prohibited:

Lighting and keeping open fires; disruptive noise, especially the playing of loud music; moving tents with ditches; disposing of waste in places other than the containers or plastic bags provided. Letting dogs walk around off lead, dog owners must ensure that their dogs do not soil the grounds, or rather they must clean up after their dogs immediately.

#### 7.) Sanitary facilities

To account for hygienic requirements, in particular, only the toilets in the banquet hall may be used. The toilets / sanitary facilities must be kept clean. Anyone dirtying them must clean up after him- or herself immediately. Please do not throw any waste into the toilet.

#### 8.) Power connection

Customary 230 V low-power connections are available. Power connection hubs may, depending on the space, be located 50-70 m away. Extension cords to reach these connections must be provided by the visitors.

#### 9.) Liability

Campers use the campsite at their own risk. The site is not guarded. The lessor assumes no liability for damages of any kind (e.g. accidents, injuries, lost or damaged items) that may occur during the use of the campsite. This exclusion of liability does not extend to cases where the damage is caused by the lessor through wilful intent or gross negligence.

#### 10.) Authority

All instructions given by the local group staff must be observed. Anyone violating the provisions of these camping rules will be immediately removed from the site.
