Important Information for the Bundessiegerzuchtschau 2025

1. Bookable categories parking places

Exhibitors can **order parking places** and tickets as of the beginning of the registration. Free sale of tickets and parking places starts by mid of July.

You as exhibitor are preferential customer for parking places for cars with trailers and tickets in all categories. **Per each entered dog one booking of a parking place** is possible.

The following categories of parking places are offered:

- Parking space S1 (direct access to the main stand, lodges and VIP area) Parking only reserved for cars for 138.00 €
- Parking space S2 Parking reserved with trailer for 145.00 €
- Parking space **S6** Parking reserved with trailer for 145.00 €

Please note: For car park S6, the exact position cannot be guaranteed due to the planned construction work on the Zeppelin Field. Therefore, on-site deviations, albeit minor, are possible. The basic location of the S6 parking space (south of the Zeppelin Field) is not affected by this.

Because of the requirements regarding checking the accommodation of the dogs only the abovementioned parking places are available at the beginning of the sale; this shall avoid empty places. Should the available places be fully booked further parking places can be sold if necessary.

The parking places must be left at latest 60 minutes after the last presentation.

Parking places for wheelchair users can be booked directly at the main office upon presentation of the corresponding proof. For this please e-mail your severely handicapped pass to bsztickets@schaeferhunde.de.

This year the parking places can also be paid per **one-off debit**, however, it has to be done through the **ticket portal**. The **direct debit SV** has on file is **not valid** for booking parking places or tickets!

Please follow the requirements of the Veterinary Office Nürnberg regarding the accommodation of the dogs in the car as well as bringing the dogs on the event area. They are explicitly valid for all dogs, regardless of, if they take part in the event or if they are visitor dogs or are carried along.

Any violation against those requirements must be documented and reported to the **Veterinary Office**. Violations lead to the exclusion from the event and the event area has to be left immediately.

2. Tickets

The purchased admission ticket entitles the holder to enter the stadium either for the entire duration of the event (event ticket) or as a day ticket for entry on any day of the event (Friday, Saturday or Sunday). The bought ticket must be exchanged for an admission wristband on site.

Please note that we still **prefer online ticket sales**. If, in individual cases, an online booking should not be feasible, it is possible to buy tickets on site. Thereby, this can lead to longer waiting periods, thus we ask you to only use this option in justified cases where online purchase is not possible.

Inside the stadium there is a free choice of seats and it is possible to switch between the main stand and the back stand.

The following categories of tickets can be purchased:

Event ticket Business-Seat VIP (adults) 79.00 €

Event tickets adults 35.00 €

Day ticket (adults) 18.00 €

Young people between the age of 14 and 18 years as well as holders of the golden membership card are entitled to a discount. This will be shown to you during the purchase process when you buy your ticket online. The relevant permission must be presented at the entrance. Children below the age of 14 are admitted free of charge (except VIP area).

How to choose your tickets:

Once you have booked your parking space, you are able to add the tickets you want to your order. If you wish to only purchase admission tickets, please click on "Other categories".

Please note:

The entry confirmation is not a valid ticket.

3. Parking places and requirements

Applicable for cars with trailers:

- Size ca. 2,20 x 7,50 m
- The parking permit with valid mobile number (will be requested when booking) has to be placed in the car highly visible.
- No campers or buses!
- The number of the license has to be entered manually into the parking permit.
- Legal and procedural regulations

Applicable for parking places for cars only:

- Size ca. 1,95 x 5 m
- Only cars.
- The parking permit with valid mobile number (will be requested when booking) has to be placed in the car highly visible.

- No trailers possible! No campers or busses, Sprinter vans etc.!
- The number of the license has to be entered manually into the parking permit.

Generally valid on-site:

The requirements of the Veterinary Office and the traffic orders of the responsible authorities are strictly to be followed. The instructions of the security guards have to be obeyed. Violation causes an exhibition ban for this event. SV reserves its right to institute an internal administrative proceeding according to the legal and procedural regulations. Should inobservance of the instruction cause harm for the club this will cause recourse against the responsible person.
